

Blac Chyna Obtains Restraining Order against "Suicidal" Rob Kardashian



Summary: Ex-lovers Rob Kardashian and Blac Chyna are feuding in court.

The Kardashian family provides a neverending saga of trashy drama, and Robert "Rob" Kardashian Jr. has finished his own chapter recently. On Monday, Kardashian and his baby mama Blac Chyna agreed to a 50/50 custody battle, despite the extreme hatred between the two.

TMZ reported that Kardashian and Blac Chyna have an unwritten agreement to co-parent their child, Dream, 8-months-old. This arrangement includes child-rearing decisions.

"Sources close to mom and dad tell us Rob and Chyna have been operating under an unwritten arrangement where they each are entitled to physical custody 50% of the time. We're told the arrangement has been "loose by consent" and recently Rob has had the kid 4 days a week and Blac Chyna picks up the remaining 3. The staff of nannies/baby nurses are always present," TMZ said.

Sources also told the publication that the two have no desire to create a formal custody agreement in court, although the two are in engaged in a legal battle for other reasons.

On Monday, Blac Chyna obtained a restraining order against Kardashian, the brother of Kim Kardashian and a fledgling sock entrepreneur. Chyna claimed that Kardashian was suicidal and had physically abused her.

The allegations were both shocking and not shocking considering how troubled Rob Kardashian has appeared throughout the years. The Kardashian brother has notably gained a large amount of weight, and on social media, he is known for attacking his own family.

Last week, though, Kardashian crossed a line when he posted [several pornographic videos on Instagram](#) of Blac Chyna as retaliation for her alleged cheating. Instagram removed the videos and banned him from their platform, and he moved over to Twitter where he wrote a series of damning tweets, accusing his ex of using him to have a baby and then cheating on him.

Celebrity attorney Lisa Bloom tweeted that Kardashian had committed the felony of "revenge porn" which is the act of publishing nude images or video of a lover without their consent. In California, where Kardashian and Blac Chyna live, a first-time revenge porn offender could receive up to six months in jail and a \$1,000 fine.

Along with attorney Walter Mosley, Bloom is now representing Blac Chyna, and they appeared together on Monday in court to obtain the restraining order. Bloom has also issued a stern warning to Chyna's new lover, Ferrari, that he too must not publish nude photographs of Chyna or he will be charged with revenge porn.

At court on Monday, Rob Kardashian did not appear, but he was represented by his attorney, Robert Shapiro, who was his father's colleague during the O.J. Simpson trial. Shapiro said that Kardashian was "sorry" and wanted to do what was best for Dream.

Rob Kardashian is the son of the late Robert Kardashian, who was a part of the dream team that got O.J. Simpson acquitted for the murder of his ex-wife, Nicole Brown Simpson.
