

Introducing the Legal Counsel Defending Trump in Lawsuit Against Bob Woodward

Former President Donald Trump's new legal representative in his lawsuit against journalist Bob Woodward is Robert Garson, chairman of GS2Law, a law firm based in Aventura, Florida, with additional offices in New York and Pennsylvania. Garson is an experienced lawyer who initially worked as a barrister in the U.K. before moving to New York and obtaining an LLM from the Yeshiva University School of Law. Garson is the president of the American Association of Jewish Lawyers and Jurists and is known for speaking out against antisemitism and discrimination. He has criticized Kanye West, formerly known as Ye, on Twitter as a "vile anti-Semite." Despite this, Garson has not commented on Trump's dinner with Ye, who brought Holocaust denier Nick Fuentes at Mar-a-Lago in Palm Beach, Florida.

Garson has taken a stance on various legal controversies, including a ban on Zionist speakers at the University of California at Berkeley School of Law. He wrote that the ban was "abhorrent and appalling" and "intellectually bankrupt." He also wrote an open letter defending a faculty member of the University of Arkansas School of Law who was told he could no longer find substitutes for Jewish holidays.

Despite Garson's successful career, he has faced some litigation snags in recent cases. He recently lost a trademark case in the U.S. Court of Appeals for the Federal Circuit and is facing a malpractice suit for work done on behalf of cybersecurity company SCE Group Inc. in its acquisition of another company. The malpractice suit claims that Garson enlisted the help of his brother, a lawyer in Australia and that SCE Group Inc. is entitled to damages under a New Jersey law that allows recovery for losses from the unauthorized practice of law. Garson has dismissed the malpractice suit as "frivolous."
